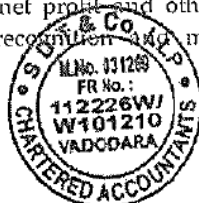

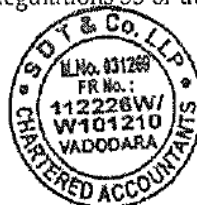
Auditor/s Responsibilities for the Financial Statements
